This tour is fully customizable when operated as a Private Tour exclusive to you (subject to availability).

The federally protected Katmai National Park and Preserve is world famous for Alaska brown bear viewing. Accessible only by air, this is Alaska wilderness in its rawest form.

Visit Brooks Falls, watch brown bears fish for spawning salmon from elevated viewing platforms and boardwalks. This 10–12-hour journey includes a lunch and a scenic 2–3-hour flight each way. Bear viewing includes walking on relatively flat paths; self guided, but National Park Rangers are available.

Note: The activity level on this tour is considered mild to moderate as it requires walking on maintained trails to get to the two main viewing platforms. Total distance is approximately 1.2 miles. The trail is mostly flat and well maintained.



Highlights

- Activity Level: Mild to Moderate – requires some walking on uneven, unpaved terrain. The total walking is approximately 1.2 miles and trail is mostly flat and well maintained.
- Intimate two-to-three-hour scenic flightseeing tour from Anchorage, flight times vary depending on weather and plane type.
- Katmai bear viewing at Brooks Falls – watch them catch jumping salmon!
- Wildlife watching on return flight for beluga whales, moose and Dall sheep

Restrictions related to this tour/soft adventure activity:

Please note the following terms & conditions and restrictions apply to participants undertaking this tour:

- **Medical/Physical, Mobility Issues:** This tour/soft adventure is not recommended for persons with heart or back condition, mobility issues, pregnant women, etc. Please let us know of any physical/health condition that you may have so we can confirm your acceptance on this tour/soft adventure.
- **Age restrictions:** Children below 6 years of age are not accepted on this tour.
- **Activity Level:** Mild to Moderate - requires some walking on uneven, unpaved terrain. The total walking is approximately 1.2 miles and trail is mostly flat and well maintained.
- **Experience:** No prior experience is required as such. You will be given proper briefing before start of this tour.
- **Check in:** Please check in at our Lake Hood Office 30 minutes prior to departure. For safety of weight and balance of the plane, we will need accurate weights of individuals or of the entire group.
- **Parking:** There is free, although limited parking at our operator's base. You will need to leave your car keys with the office. Our operator also picks up from major hotels. You are welcome to leave baggage at the operator's office at no additional charge.
- **What to bring:** Sunglasses, bug spray, camera and binoculars. Dress comfortably and in layers; Alaska weather can change dramatically. A sunny and warm day in Anchorage can turn windy, rainy, and cool in the National Park. Please bring prescription medications.
- **Other information:** Katmai National Park is in a remote area accessible only by plane so many of the common expectations of "civilization" are not available. You should bring essential medications with you and not plan plane connections on the same day of this trip. Additionally, if visiting Katmai is extremely important to you, please allow time in your schedule for possible rescheduling of this trip. Rust's flies through two mountain passes to reach Katmai and this trip does sometimes cancel due to weather.
- **Waiver:** In most cases, signing a Waiver is required. Your tour/soft adventure includes components that is considered as a soft adventure activity, and therefore you are required to sign a Liability Waiver issued by the operator of that tour or soft adventure activity. This requirement will be clearly indicated at the time of booking and on your tour voucher. Additionally, for all participants under the age of 18, a parent or legal guardian must sign the Waiver on their behalf.
- **Should we purchase Travel Insurance?** Clients are absolutely required to be in possession of sufficient travel insurance to cover all eventualities including, but not limited to accident, medical, etc.

Highlights

- Our fly out Katmai bear viewing adventure takes you to Brooks Falls, where three bear viewing platforms connected by elevated boardwalks allow for close, unobstructed and extraordinary bear viewing in Katmai National Park. In July, lured by spawning salmon, as many as fifty bears can be seen at once along the 1.5-mile Brooks River.
- While the Katmai bear viewing at Brooks Falls is self-guided, Katmai National Park Rangers provide an initial briefing upon arrival and are available throughout the park for questions. An on-site wait list for the Lower River bear viewing platform may be implemented when visitation reaches capacity to ensure quality bear viewing. What this means is that sometimes the bear viewing is crowded, and the ranger may ask you to move to another platform. There is plenty of room in Katmai overall to see bears.

FAQ

- **Is this a private or a shared experience?** This tour/soft adventure activity is a shared experience. There will be other participants on this tour/soft adventure activity.
- **Is this tour customizable?** Subject to availability, we can operate this tour/soft adventure activity as a fully customized Private Tour experience, exclusive to you. Additional costs will apply. Please check with us for more details.
- **Are there fixed dates of departure for this tour?** Yes. There are specific dates in the season when this tour operates.
- **Is it necessary to sign a Waiver to participate in your tours?** In most cases, signing a Waiver is required. Your tour includes a component that is considered a soft adventure activity, and therefore you are obliged to sign a Liability Waiver issued by the operator of that tour or activity. - **Are there any specific dress code requirements for participating in the tours?** There are strict dress code guidelines that must be followed for safety purposes. These specific requirements will be communicated to you at the time your tour is confirmed.
- **Is it safe to undertake this tour if I have a certain health condition?** The nature of certain tours and soft adventure activities is such that clients with heart, back conditions, mobility issues, pregnant women, etc should refrain from participating in such tours and soft adventure activities. This information will be pointed out to you under restrictions.
- **Are children allowed to participate in certain tours and soft adventure activities?** Yes. Once again, such restrictions are pointed out under “Restrictions”.
- **Can we expect to see wildlife on these tours?** While there is always a chance to spot wildlife during our tours, and such sightings are not uncommon, we must clarify that seeing wildlife is not a guaranteed aspect of our tours. Our guides possess extensive knowledge about the animals in the park and will gladly share information about them, should you see any wildlife or have questions about the local fauna.
- **Is it safe to approach or touch wild animals based on their behavior?** Absolutely not. Under no circumstances should you approach, touch, or exit your vehicle to photograph wild animals, regardless of their apparent calmness or friendliness. Interacting with wild animals poses significant risks to both humans and the animals themselves.
- **Is it mandatory to present Service Vouchers received from DMCi for availing confirmed services during our tour, including hotel accommodations and tours?** Yes, it is mandatory. To avail of the services confirmed for your tour, including hotel accommodations and tours, you must present a digital or printed copy of the Service Voucher provided to you by DMCi or your travel agent at the time-of-service confirmation.
